**Preamble:**

All answer scripts of PG degree and diploma courses of Medical, Dental, Ayurveda & Homoeopathy subjects were used to be subjected for four valuations independently by two internal and two external examiners as per the ordinance as shown under reference no.1 supra. University now has adopted digital valuation of answer scripts for April/May 2015 Post Graduate examinations. The Academic Council in its meeting held on 28.05.2015 recommended for double valuation of answer scripts for all PG courses. The Syndicate in its 113<sup>th</sup> Meeting approved the recommendations of the Academic Council. Hence, this Notification.

**NOTIFICATION NO. AUTH/Exam/Val/PG/24/2015-16 dated 01.07.2015**

In exercise of the powers conferred under section 35 of RGUHS Act 1994 and in supersession of earlier notifications issued in this regard, Syndicate notified that the answer scripts of all Post Graduate Degree and Diploma courses of examinations shall be subjected for TWO valuations independently by two eligible examiners and average of two marks shall be considered for computation of results. If the difference of marks between two valuations is  $\geq$  (More than or equal to) 15% , such answer scripts shall be subjected for third valuation and in such cases the average of highest two marks shall be considered for computation of results.

This notification shall come into force with immediate effect.
