### Preamble:

The Notification for ELECTION OF THREE MEMBERS OF THE FACULTY OF MEDICAL COLLEGES AFFILIATED TO RAJIV GANDHI UNIVERSITY OF HEALTH SCIENCES, KARNATAKA ,BANGALORE TO THE MEDICAL COUNCIL OF INDIA BY THE SENATE was issued on 26.02.2015 fixing the calendar of events subject to the Orders of Supreme Count of India in CA Nos. 1119-1120/2015 on the file of Hon'ble Supreme Court of India – W.A. Nos.5541-5542/2013, on the file of Hon'ble High Court of Karnataka. The last date for filing the nomination was fixed as 11.03.2015.

The nominations submitted by the candidates were subjected for scrutiny and all the six nominations were found valid and same was notified on 11.03.2015. The ELECTION OF THREE MEMBERS OF THE FACULTY OF MEDICAL COLLEGES AFFILIATED TO RAJIV GANDHI UNIVERSITY OF HEALTH SCIENCES, KARNATAKA ,BANGALORE TO THE MEDICAL COUNCIL OF INDIA BY THE SENATE was held on 23.03.2015 between 11.30 a.m. to 1.30 p.m. as per the calendar of events of the said Election Notification. The counting was held at 2.30 p.m.
