Sub:- Valuation of answer scripts of P.G. courses by four eligible examiners.

Preamble:

All answer scripts of PG degree and diploma courses of Medical, Dental, Ayurveda & Homoeopathy subjects were used to be subjected for four valuations independently by two internal and two external examiners as per the ordinance as shown under reference no.1 supra. University now has adopted digital valuation of answer scripts for April/May 2015 Post Graduate examinations. Due to technical difficulty, digital valuation could not be commenced during conduct of practical examination in time and some of the external examiners drawn from other universities outside the state could not value all the answer scripts. The matter was communicated to committee of Academic Council in its meeting held on 17/05/2015. CAC recommended to get the answer scripts valued by any four eligible examiners since the answer scripts are in the coded form and identify of the candidates is not revealed.

The recommendation of CAC was communicated to the members of Syndicate by circulation. The considered opinion of the Syndicate is to get the answer scripts valued by any four eligible internal examiners. Hence this notification.

NOTIFICATION

In exercise of the powers conferred under section 35 of RGUHS Act 1994, Syndicate notified to subject the answer scripts of Post Graduate Degree and Diploma courses of the April/May 2015 examination for four valuation independently by four eligible internal examiners.

This notification is applicable for the April/May 2015 Post Graduate examination and shall come into force with immediate effect.
