In the exercise of the powers conferred by section 35(2) of RGUHS Act 1994, the syndicate in its 113th meeting held on 26.06.2015 is pleased to revise the eligibility criteria for admissions to the M.Sc. Echocardiography Technology & M.Sc. Perfusion Technology and the duration of the courses as follows:

EXISTING	AMENDED
The duration of the courses of M.Sc. Echocardiography Technology & M.Sc. Perfusion Technology is increased to 3 years from 2 years.	The duration of the courses of M.Sc. Echocardiography Technology & M.Sc. Perfusion Technology is decreased to 2 years from 3 years
The candidates securing minimum 50% of marks in aggregate in B.Sc Natural Science courses are eligible to take admission to I year of M.Sc. Echocardiography Technology & M.Sc. Perfusion Technology The candidates possessing Bachelors degree in Allied Health Sciences and MBBS degree are eligible for Lateral Entry to II year directly	Candidates securing minimum of 50% aggregate in B.Sc Perfusion Technology for the M.Sc Perfusion Technology course and B.Sc. Cardiac Care Technology for the M.Sc Echocardiography course respectively are eligible to take admission to I year of the two year course.
