In exercise of the powers conferred under section 35 of RGUHS Act 1994 and in supersession of earlier notifications issued in this regard, it is notified that the valuation of answer scripts of Post Graduate Degree and Diploma Courses of Medicine, Dentistry, Ayurveda & Homoeopathy examinations shall be as under: -

- a) All answer scripts shall be subjected to FOUR valuations independently by FOUR eligible examiners.
- b) In the answer script, if the difference in the marks awarded between four evaluators is equal to or more than 15%, such answer scripts shall be referred to 5th valuation.
- c) The best four marks out of the five valuations shall be considered for arriving at average marks for final computation of the results.
- d) The marks awarded and the results declared as per this notification shall be final.

The above modification shall be applicable for the examinations conducted during May- 2017 and onwards.
