Preamble:

RGUHS was established in the year 1996 by an Act of Karnataka Legislature called RGUHS Act 1994. The colleges conducting Health Sciences courses which were affiliated conventional Universities in Karnataka were carved out and were affiliated to RGUHS. All these colleges are on annual affiliation. Some of the colleges are 40-50 years old. The statutes governing granting permanent affiliation were framed by Senate and sent to Chancellor through Government. Chancellor assented the statutes and was gazetted dated: 08.03.2001.

Meanwhile no college/institution affiliated to RGUHS applied for grant of Permanent affiliation and University has been conducting annual inspection and granting annual affiliation.

The number of colleges/institutions affiliated to RGUHS has increased from 210 in 1996 to over 650 in 2016. University is finding it difficult to arrange for LIC inspection, placing the reports before the appropriate authorities and communicating the same to the colleges concerned. The statutes framed were not made use of due to lack of proper guidelines for the operation of the same. Hence, Syndicate in its 110the meeting held on 21.11.2015 constituted a committee to study and frame proper guidelines for granting permanent affiliation in accordance with provisions of RGUHS Act 1994 and the statutes drawn there under. The committee met several times and after detailed discussions, submitted its report on 08.11.2016.

The recommendations of the Committee regarding guidelines for the grant of permanent affiliation were accepted by the Syndicate in its 124th meeting held on 06.01.2017. Hence, this notification.

NOTIFICATION

"In exercise of the powers conferred under section 35 of RGUHS Act, 1994, the Syndicate is pleased to notify the guidelines for grant of permanent affiliation in addition to other provisions of the statutes governing grant of permanent affiliation as shown below:

General & Administrative:

- 1. Institution must be in existence for the last 15 years (Existing Rule of 5 years to be amended).
- 2. Track record of the institution Uninterrupted affiliation/recognition is a must. Any interrupted affiliation/suspension/affiliation withdrawn/approval withdrawn by Apex Bodies etc shall be taken note of (Undesirable).
- 3. Accreditation by NAAC (Desirable).
- 4. Governing Council constituted with adequate representation from the society & the faculty.
- 5. Provision for separate hostels, colleges vans, labs, library, computer and other facilities in adequacy.

Fee:

- A) 3 years of existing affiliation fee to be collected in advance for the existing intake in UG/PG etc.,
- B) Any fresh course or Any increase in intake for existing UG/PG during the next 3 years Inspection will be held for the said course only and fee as per increase in intake.

Academic Standards:

- 1. Courses offered UG, PG, Fellowship, Certificate, Super specialty, Ph.D etc
- 2. Academic performance of the students for last 3 years
 - a. Result pass percentage UG/PG
 - b. First class, Distinction, Rank, Gold Medal
 - c. Number of Research projects funded by agencies ICMR, DRT- etc
 - d. Intake fixed and students admitted for last 3 years (Ratio)

Faculty — 3 years: (A Detailed report to be obtained)

- a) Number of Publications in Index Journals (Pubmed, NLM etc)-National/International
- b) Number of presentations in National/International conferences/ Seminar/ Workshop
- c) Number of Faculty Development Programs conducted by college, attended by faculties.
- d) Number of Research Projects- funded by Institute/Agencies such as ICMR/DST etc.,
- e) Number of Text Books Written/contribution.

f) Participation in Public Health Programmes, Rallies, Radio/TV etc., NSS Programmes

<u>Extra Curricular – Sports/Cultural, Students/Staff (detailed report to be obtained):</u>

- 1. Students/faculty involvement in non-teaching welfare programm ϵ , PF, Insurance
- 2. Incentives for presentation/publication, scholarship/Financial Assistan > to deprived class of students
- 3. Proceedings of Anti-Ragging Sexual harassment Committee.
- 4. Permanent Principal as per the norms of Apex Bodies.

This Notification shall come into force with immediate effect.
