(1)	It was decided by the Syndicate to place it before the Finance Committee for granting Ex-gratia amount of Rs. 5,00,000/- to any faculty if he dies during the carrying out the assigned University related work.
(2)	Prof. Ramachandra Shetty, Syndicate member said that in the 174 th Syndicate meeting subject No. 174/2, the Syndicate has decided to write a letter to the Government regarding the construction & extension of RGUHS Regional Centre at Davangere for approval needs to be reverified in the present Syndicate meeting because many of the open universities have retained the power of calling the tender for such constructions on their own. If we continue to take a permission from the Government, there will be an undue delay in the process and also the power of making decision by the Syndicate like any other self financing autonomous Universities will be given to the

Due to the COVID-19 Pandemic and heavy rains there was delay in the completion of RGUHS Regional Centre at Davangere. The Syndicate unanimously decided to give time extension for the construction of RGUHS Regional Centre at Davangere.
(3)	It was decided to call for online application for forthcoming fresh/continuation /increase intake/additional courses in all faculties. The institution will upload all the documents online. The LIC team should verify the original documents during the LIC inspection. All the three members of LIC team should verify & certify the original documents.
(4)	It was unanimously decided in the Syndicate meeting that an endorsement with reasoning for nursing colleges which were not recommended in the 172 nd Syndicate meeting should be sent as per the observations of the scrutiny committee which was upheld in the decisions of CAC which was held on 25 th , 26 th and 29 th of August 2022 and 3 rd September 2022.
(5)	It was unanimously decided to give Rs. 5,00,000/- towards the National Conference conducted by the Akhila Bharatha Rashtriya Shikha Mahasang -2020, the conference is focused on National Educational Policy-2020.
(6)	The MOU between RGUHS and Karnataka State Pharmacy Council regarding orientation programme for PG students of University in the name of Pharmadisha was placed before the Syndicate for approval. After thorough discussion, it was unanimously decided to approve the MOU postfacto. The MOU shall be sent to the Finance Committee for approval and to settle the bill of Rs. 3,20,000/-
