





- (f) As per NMC assessment documents internal assessment which has to be submitted to the University as a proof of eligibility to appear for University examinations is 100 marks each for theory and practical's, in all the subjects of MBBS except surgery, medicine and OBG in which internal assessment has to be 200 marks each for Theory and Practicals. These marks will appear in the marks as a separate heading. These marks will not be added to those obtained in the University exams. These marks will not be taken into account for calculating pass percentage, assignment of first class or distinction and for the award of gold medal.
- (g) As for the GMER there should be atleast 1 internal assessment exam in every year that the subject is taught and 3 internal assessment exam, in the year that the University exam is held for that subject. The last of the 3 **IA** exams should be conducted as per the University pattern.
- (h) At the end of every clinical posting, an end-of-posting exam should be held, as part of the internal assessment of clinical skills and clinical one exam prior university examinations as per the university exam pattern. The average of the of the theory IAs and practical IAs will be calculated for eligibility for University examinations.

Decision: The members accepted this unanimously and these will be the instructions regarding internal assessment in the new curriculum of 3rd MBBS Part 1&2.






