However, the committee observed that there is short collection of total fees compared to the previous year's collection. The Committee also directed Registrar to place the reason for the short collection before the next Finance Committee Meeting. The Committee also recommended that the Registrar should get the following works done with immediate effect.

- Maintenance of DCB in all the sections, from where the RGUHS receives the Income.
- Maintenance of Asset Register and getting the assets valuated annually from the authorized third party.
- Up gradation of existing software in Finance Section, through tender process as per Rules.

ATR:- There is a short collection of Rs.30.00 Cr from Bank Interest in the FY 2020-21 due to decrease in bank rate of interest on investment and Rs.16.00 Cr revenue pertaining to the financial year 2018-19 was collected in the financial year 2019-20. Hence there is a shortfall of revenue collection in the year 2020-21. Maintenance of DCB in all sections, and maintenance of Asset Register - its annual valuation and upgradation of Finance Software will be undertaken after due discussions with the concerned sections. The subject is approved by the Syndicate in its 165th Meeting held on 25.11.2021.

Annual increment to the programmers in examination (Computer Section) who are working on contract basis:

As the subject was already approved in the 162nd Syndicate Meeting, the committee ratified the subject.

ATR:- The subject was already approved in 162nd Syndicate Meeting and Finance Committee ratified the same.

ATR:-The subject is approved and once the notifications are issued and the bills are submitted to the Finance Section, the action will be taken at Finance Section.

Payment of extra remuneration / overtime allowances to the Officers and officials of RGUHS and to the employees deployed through outsource agency and to the menial staff:

The Finance Officer and Secretary informed the Committee that subject pertains to the extra remuneration / overtime allowances of different sections under Evaluation. He also informed that some of the expenditure on these subjects are being wrongly spent by the sections concerned after getting the administrative sanction. Finance Officer told that, by quoting the Govt, Order No. HFW 494 RGU 2015, Bangalore, Dt. 08.03.2016, some expenditures are being booked illogically.

Committee discussed about the points raised by the Finance Officer in detail. The Finance Committee, by majority has agreed to continue the formalities which are being followed at present on need basis. It agreed to provide small hospitality in the form of tea / coffee / biscuits / snacks etc., to the guests coming to web streaming section on duty and also to all the members of the committees / sub committees, who come to attend the meeting, as recommended by Registrar (E) and sanctioned by Registrar. However, it instructed the Registrar (E) to be judicious in recommending the same.

Approval of Budget Estimates for the FY 2022-23 and Revised Estimates for the FY 2021-22:

The Chairman asked the Finance Officer and Secretary to explain about the Revised Budget Estimates (RBE) for the FY 2021-2022 and Budget Estimates (BE) for FY 2022-23. Finance Officer and Secretary told that, as per Section 13(6) and Section 42 of RGUHS (Amendment) Act 2013, Vice-Chancellor shall be responsible for the presentation of the Annual Financial Estimates to the Syndicate. As per Section 17(3), Finance Officer shall be responsible for the preparation of the Annual Financial Estimates. As per Statute 4.2, under the Head, "Functions of the Finance Committee", it is said that the Finance Committee shall scrutinize the Annual Budget Estimates and make its recommendations to the Syndicate. The Finance Officer told that hence the Revised Budget Estimates for the FY 2021-22 and Budget Estimates for the FY 2022-23 is placed before the Finance Committee, a copy of which, is already sent to the members of the Finance Committee along with the Agenda to discuss in detail. Both the RBE and BE are prepared after consulting the Directors and Section Heads of the University.

The Finance Officer explained that in the RBE for the FY 2021-22, the total Income (Receipts) including the interest on FDRs will be Rs.22,917.99 Lakhs and total expected expenditure will be Rs.18,230.28 Lakhs. Hence net excess of Income over expenditure will be Rs.4,687.71 Lakhs. The Committee approved the RBE for the FY 2021-22 as in the **Annexure 'A'** attached with an amendment by keepingRs.625.09 Lakhs as expected expenditure and Rs.800.90 Lakhs as RBE for the FY 2021-22 under the Head of Account 02004008 (Establishment of Museums in 08 Government Medical Colleges (six Departments) ending up the total revised Receipts (Income) of Rs. 22,917.99 Lakhs, including (Bank Interest on FDRs) and total expenditure at Rs 18,855.28 Lakhs.

Finance Officer explained to the Committee that in the BE for the FY 2022-23 (as in the attached Annexure 'A') the total income including the bank interest on FDRs is Rs.22,468.50 Lakhs and the total expenditure is Rs.69,139.30 Lakhs, because of which there is Rs.46,670.80 Lakhs of Net excess of expenditure over Income. He also explained that out of excess expenditure of Rs.46,670.80 Lakhs, assets worth of Rs.36,140.00 Lakhs will be created, (Rs.31,140.00

With this amendments Committee unanimously passed the Budget Estimate for the Financial Year 2022-23 as attached in **"Annexure -A".**

However the Finance Committee observed that there is a deficit of Rs. 5,430.80 Lakhs, (after reducing the estimated expenditure as said in the above table) which has happened because of the excess of expenditure over the Income. Committee recommended to utilize such deficit amount of Rs.5,430.80 Lakhs from the investments kept in the form of FDRs and also unanimously decided to go for the 'Revision of Fee's as early as possible, because no such revision has happed since 15 years (approx). Approval of Annual Accounts of RGUHS for the Financial Year 2020-21 after 10 (B) audit:

Finance Officer with the permission of the Chair has presented the revised Annual Accounts. He told that earlier the Annual Accounts for the Financial Year 2020-21 was approved in the 77^{th} Finance Committee Meeting held on 1^{st} September 2021 and in 165^{th} Syndicate Meeting.

After the approval is sought, the Annul Accounts were produced for 10(b) audit. The Tax auditors suggested few book adjustment transactions to be made in the books of account and the same was implemented and Annual Accounts were revised finally and the Finance officer and Vice Chancellor have signed the revised Annual Accounts for filing the return of income for the University under Income Tax Act, 1961.

The Final Annual Accounts for the FY 2020-21 is containing total revenue of Rs. 2,09,12,19,011 and total expenditure of Rs. 1,22,22,56,157. The difference in revenue of Rs. 1,53,88,130 is due to recording the Interest on FDs of Pension Trust Fund wrongly credited to RGUHS bank account, now considered as income (earlier was parked under liability) in the hands of RGUHS and difference in expenditure of Rs. 10,11,43,504 is due

Secondly, he also requested that inspection for new colleges for Fresh Affiliation which is received from the University has not taken consent from the Members of Syndicate, RGUHS as per statutory act of RGUHS the syndicate Members have to form a inspection Committee with Hon'ble Vice Chancellor to finalize the report.

In view of the above, Dr.K.Venkatagiri requested to have minimal agenda for the syndicate meeting on 14th March 2022 and consider towards fulfilment of the proposals given.

Hon'ble Vice-Chancellor informed the members that the applications regarding fresh affiliation placed before this Syndicate had applied for the year 2020-21 & 2021-22. However, due to non submission of documents on time and because of few administration issues these applications were not placed before previous Syndicate meeting and as the admission procedure for many courses is getting completed on 31.03.2022. There was a necessity to consider the applications for granting fresh affiliation, hence, these matters are taken up on urgent basis following RGUHS Act & Statutes.
