





The whole team congratulated the efforts put by the teachers in getting the results out on time and also conducting the practical exam smoothly. (iii) The BOS members thanked the university officials for their support and amended to bring the best to the profession in the near future.



- i. ***To place the Latest happenings on the Fixed Deposit made in Sep-2014 in the then Syndicate Bank (present Canara Bank), M. S. Building, Bangalore Branch.***

Decision: The Committee observed in detail about the happenings that has happened with the Fixed Deposit of Rs.10.00 Crore kept in the Syndicate Bank, M S Building Branch, Bangalore (Now Canara Bank) in 2015 and decided to go further as per the Directions of Government of Karnataka, Paper Laid Down Committee. It has also instructed the Legal Officer / Consultant of the University to speed up the matter which is pending in ACMM's Court and also in Hon'ble High Court and the Legal Officer of the University shall advice Hon'ble Vice-Chancellor in all these Court Cases related with the Fixed Deposit Kept in Syndicate Bank and the Registrar of the University has to co-ordinate this matter after consulting with the Legal Consultant of the University. If required, Legal Officer may consult Finance Officer also on the subject.

Regarding Closing of Pension Trust Account maintained at Canara Bank, Tilak Nagar, Jayanagar, the Committee has agreed to the directions of the Paper Laid Committee of GOK. And agreed the Finance Officer's already taken action of closing the Pension Trust Account maintained at above said Canara Bank and transferring of the closed account proceeds temporarily to the existing SB Account No. 64169884707 in SBI (in which the closed proceeds of Canara Bank is already credited). And also, As action of transferring the pension Trust Fund to the existing SB Account No. 64169884616 (both the bank accounts are maintained at SBI, Jayanagar 4th Block) to have a permanent Pension Trust Account entirely in the name of PENSION TRUST, which shall be called as PENSION TRUST FUND ACCOUNT (SB Account No. 64169884616) maintained at SBI, 4th T Block, Jayanagar.

Action: - SB Account No. 64169884616 maintained at State Bank of India, Jayanagar 4th T Block is treated as Pension Account as per RGUHS Books of Account.

ii. Implementation of new Finance Package:

Decision: The Finance Committee discussed in detail and thought that the up gradation of 'Software' or implementation of New Finance Package to ease the payment system and to have accuracy is the demand of day on urgent basis. It opined that University should upgrade its technology. It agreed to all types of Budget proposal for the same and approved Rs.50.00 lakhs for the up gradation of proposed software at present and also authorized the Hon'ble Vice Chancellor to give approval for some more Budget/amount for the proposed subject (under discussion). If occasion demands, Committee observed that, this type of up-gradation of new software technology should not be stopped in want of administrative approval. Hence authorized Hon'ble Vice Chancellor to take decisions for

software development and give approvals up to Rs. 25.00 lakhs in each case and gave approval for new Finance Package, DCB, Asset Register and Stock Book online.

Action : The Finance Committee felt that the notings made and sent to all the members of the Finance Committee is not required under this "action". And it is agreed to change the 'action ' like this – The Tender shall be called immediately (even short term tender of 7 days notice) under the nomenclature '**Upgradation of Finance Management System including online payments and receipts through multiple payment gateways**'.

iii. Information on the Audit of all the investments made from 1996-97 to 2013-14.


Decision: The committee observed the Lacunas in the maintenance of records in the by gone years and understood the handicappedness of the Audit firm in carrying out the audit. Hon'ble Vice-Chancellor and the Chairman of the Committee has told that sufficient time should be given to the Audit firm and even if they require some more time, the same may be given to the Firm. He told that if RGUHS can find out even only one FDR which is not accounted so far, that is worth. The Committee expressed happiness on the audit work, and unanimously agreed to extend the timeline, if the firm requests for some more extension, the committee authorised Finance Officer to give such extension of audit period after the approval of Hon'ble Vice Chancellor.

Action:- The CA firm requested for the extension of time for digitalization of Fixed Deposit Register. Accordingly extension is granted as per order no RGU/PROC/Audit/FDR/111/2021-22 Dated 01.12.2022 upto the end of February 2023

iv. Ratification of action taken for payment of Rs.10,00,000/- made to Sri. D.N. Nanjunda Reddy, Senior Advocate, Bengaluru towards Professional Fees for appearance in W.P.No. 1904/2022 and other connected Writ Petitions before Hon'ble High Court of Karnataka, Bengaluru.

Decision: The Committee ratified and approved Rs.10,00,000/- (Rupees Ten Lakhs) paid to Sri D N Nanjunda Reddy, Senior Advocate. While discussing on the subject Finance Officer drew the attention of the Committee, saying that at present in the University there are no Notifications regarding the Fee for the Advocates / Senior Advocates, who are not in the University's empanelled list, but to whom some cases are handed over, especially for expertise opinion or to represent the case in the Hon'ble Court. 

Decision: Finance Officer has objected the present practice of giving the grants to affiliated institutions in the name of the Principal, in lieu of sports activities. He told that, in the present practice, the amount for sports activities is being released to the Principals on AC Bills. The NDC Bill for the expenditure is supposed to be submitted to Finance Section before one month after the release as per Rules. But no such follow up action is being done either from any officials of RGUHS or from the Deputy Registrar, Sports. Till date no discussions are held in Finance Committee on such advance releases to sports activities. Since the money is released in advance to the concerned colleges, there are chances of non-submission of proper bills/ vouchers along with NDC Bill and also exact accountability cannot happen. The Finance Officer requested the Committee to stop paying in 'Advance' for all Sports activities.

The Committee had a detailed discussion on the subject and decided to go ahead with the present practice of releasing "Advance" for the sports activities in the name of the Principals. And also, committee directed the Registrar and the Deputy Registrar Sports (the officer in-charge of sports) to take the responsibility of collecting the Bills / Voucher from the concerned Principals and submit the same to Finance Officer as per Rules. If the bills

/ vouchers are not submitted with NDC Bills to Finance Officer on time, the

x. Academic Assurance Scheme-RGUHS

This scheme is applicable only in such cases where parent/guardian is the sole breadwinner of the family and because of death of the breadwinner of the family and ensuing financial difficulties, the students will be given financial assistance for completing their course. This Scheme is applicable

to Karnataka students admitted to Government College and Government seat in private college (as per the RGUHS guidelines towards this scheme).

RGUHS shall pay only the Financial Aid to the extent of fee prescribed by the government during the current year and rest of the course duration time to time excluding internship period (as per RGUHS guidelines for Academic Assurance Scheme). The Budget Allocation: - The University has deposited Rs.20 crores as corpus fund in bank as fixed deposit to pay Academic Assurance Benefit to eligible student from the generated interest.

Decision: *Committee ratified the subject of paying Financial Aid up to the extent of the fees prescribed by the Government, issued from time to time, during the current year and also for the rest of the course excluding the Internship period as per the RGUHS guidelines issued under Academic Assurance Scheme vide Notification No.RGUHS/SWF/MISE-05/ESL/2020-21 Dated 15.09.2022 (Ver 1.2)*

Action : Director, SWF, RGUHS

xi. Award of Scholarship to UG Students of RGUHS

RGUHS Scholarship is introduced as a flagship program to award Scholarship to Under Graduate students of Health Sciences faculties studying in affiliated institutions. The objectives of this scheme are to provide financial assistance to the poor and meritorious students to meet a part of their expenditure while pursuing UG course.

Amount of Scholarship per annum: *The scholarship amount for each student under various faculties shall be as follows:*

Finance Officer told to the Committee that before enhancing / revising any hike for the services related with exam or LIC etc., the committee must see that there is a 'deficit' of around Rs. 52.00 Crores in the Budget of 2022-23. If 'hike' is effected, then the 'Deficit' will be more. He also told that this is not a 'healthy' financial management. Hon'ble chairman and Vice Chancellor told that at present, better to give approval for the Road Mileage Allowance at the rate of Rs. 15/km, since there is sharp hike in fuel price, which is at present @ Rs. 10/km. This Road Mileage Allowance rate shall be applicable for all types of duties of RGUHS. The members present supported and gave approval for the same. But the committee opined that other issues, like hiking the accommodation charges, LCA etc., will be taken up only after making 'provisions' to overcome the present "Deficit" budget. The rate of Road Mileage Allowance @ Rs. 15/km will take its 'effect' from the date of notification and apply to the 'claims' coming for pricing after that. The committee opined that the Syndicate approval and the 'Notification' in this regard is a must. After that only the same shall be put into practice.

Action: Registrar, RGUHS has to notify after the Syndicate approval.

Decision: Committee discussed the same and present system of service being provided by such centers at private colleges. Finance Officer opined that it's once again a 'burden' on the Finance. But the members opined that till RGUHS opens its own Regional Centre and depute/appoint its staff over there, the services of the Private colleges are required and the 'Honorarium' involved for such services is very meagre. Hence, committee approved the monthly honorarium to such personnel involved in each such center as shown below:

- xv. **The subject is placed before the Finance Committee with regard to payment of Rs.12,00,000/- to Sri.D N Nanjunda Reddy, Senior Advocate, Bengaluru towards Professional Fee for appearance in WP No.1904/2022 and other connected WP before Hon'ble High Court of Karnataka, Bengaluru.**

Decision: The Committee discussed on the same elaborately. Since sometimes because of the need of the hour University has no other choice but to consult some experts in the field with the sole intention of representing the university properly. In such cases, the Fee charged by such Senior Counsels / Experts is not 'unique'. But, in the interest of the students / University, though Fee charged is high and though there is no Notifications from the University prescribing the 'Legal Fee', still in such cases the administration has to react. Hence the Members present authorised the Hon'ble Vice Chancellor to decide and fix the Fee and pay accordingly, in future and also though there are no provisions to pay such Legal Fee 'in advance', but to get the things done fastly and to act on time, it is decided to pay the amount in advance on the demand raised by the Advocates. Finance Officer is directed to release such Legal Fees approved by the Hon'ble Vice-Chancellor.

Action:- After the due approval from the concerned Officers the payment was made on 18.11.2022

- xvi. **Refund of excess/double payment of any fees etc., paid by the students:**

Decision: After detailed discussion, the agenda put up by the Deputy Registrar's, Ayurveda is approved by the Committee as it is and the process of accepting is 'Syndicate' and a notification of the same there by the Authority section shall be followed. If the notification is done, Finance Officer shall return all such 'Fees' in arrears also.

xviii. Proposal to increase the fees to be paid to the University towards the change of College address:

Decision: The subject was placed for ratification, as the subject was already approved in the 173rd Syndicate meeting held on 27.09.2022. The Syndicate decision was- "Committee approved to collect the fees (ratified changes to the fresh affiliation fees from that course/colleges) for changes of colleges address for all the courses/colleges as approved by the Syndicate in its 173rd Meeting held on 27.09.2022". The Finance Committee discussed on the Syndicate decision and ratified / approved to increase the application fees for the change of address received from all affiliated colleges for all courses / colleges from existing fees of Rs.25000/- to the amount fixed for the fresh affiliation fees of such courses / colleges.

Action:- Notification in this regard yet to be issued by the Authority Section.

xix. Fixing of distance for Local Conveyance Allowance:

The Committee discussed in detail about fixing of distance in Kilometers for claiming Local Conveyance allowance.

Decision: The Committee decided to continue the same what University is following, i.e., If the examiners travels within 40 Kilometers from the present working college to the examination Centre, he can claim Local Conveyance Allowance, 40 and above Kilometres, examiner is allowed to claim road milage allowance (Travelling Allowance) i.e, Rs.15/- per Kilometre for any work assigned by RGHUS. And also if the gap between the two exams in the same place is more than two days, then the examiner is allowed to claim TA / RMA for the second time also for up and down to the place of duty from his college. If the gap is less than two days, then the examiner can claim only DA maximum for two days.

Action:- Notification in this regard yet to be issued by the Authority Section.

xx. *Revision of payment to the examiners who are attending NA papers.*
At present in Finance Section the bills are being received for NA paper valuation. As per present Notification of RGUHS, Rs.5.00 per NA paper multiplied with number of valuated NA paper or minimum Rs.500.00 per day whichever is more is being paid to the valutors while paying Digital Valuation Remuneration. Apart from this digital valuation bills, Colleges are also claiming NA paper valuation remuneration through separate bills. While pricing these bills, the remuneration already paid for NA paper valuation in the digital valuation bills are being deducted out of the applicable remuneration in the college bills and the balance amount is being paid. But the loss noted for the University is though only one NA paper is evaluated in a day, the University is paying minimum Rs.500/- towards remuneration to each examiner. To overcome this loss, FO suggested, the minimum remuneration of Rs.500/- should be reduced. The Committee after detailed with the Finance Officer, decided to pay Rs.5/- per NA paper valuation as it is. But, decided to fix Rs.100/- per day as minimum remuneration, instead of present remuneration of Rs.500/- per day.

Action:- Notification in this regard yet to be issued by the Authority Section.

SUBJECT NO.II:

Action taken on the Subject No. 172/43 of 172nd Syndicate Meeting held on 02-09-2022, i.e, to disinvest and cut off relationship with Canara Bank.

As per the direction of the Paper Laid Down Committee, letter was written to Canara Bank (the then Syndicate Bank) authorities. But, the Chief General Manager, Bangalore Circle, Canara Bank, in his letter dated 02.09.2022


written to RGUHS, has told that Canara Bank is unable to refund the amount of Rs.8.50 Crore + Interest at present. Still RGUHS had filed complaints with OMBUDSMAN of RBI, who inturn rejected the complaint of RGUHS, saying that ' complaint is rejected under Clause 16 (2) (a), of the Reserve Bank – Integrated Ombudsman Scheme – 2021. In the opinion of the Ombudsman, there is no deviancy in service'.

Decision of the Syndicate and Action taken thereof:

a. **Rs.150.00 Crores which is invested in Canara Bank in the month of January 2022 should be withdrawn after following the due process of writing a letter to the Branch of Canara Bank, Nelamangala Branch, Bangalore.**

Bk/Misuse/35/fd/2015-16 dated 12.09.2022 to return Rs.150.00 Crore immediately, which was Invested in Canara Bank, Nelamanagala Branch, to which, the said bank has sent a mail dated 12.09.2022, as reply saying that the Investment made by RGUHS on 31.01.2022 is kept under different categories of Investment. The one being under 'non callable', i.e, Rs.100.00 crores, cannot be returned until 31.01.2023. Because non-callable term deposits are bulk deposits where premature withdrawal is not permitted. The other one being under 'callable' category, i.e, Rs.50.00 Crore is returned with applicable rate of interest as per banking norms. It also informed that Rs.100.00 Cr kept in non callable category will be returned on 31.01.2023 with interest on maturity.

The same information is already passed to the Government and to the Paper Laid Committee vide RGUHS letter no. Ar gi yu/ha vi/Ka Pa Sa/2022-23 dated 24.09.2022.

- b. The SB a/c in Canara Bank i.e., the Pension Trust Account Should be closed and shifted to SBI, Jayanagar 4th T Block, Bangalore Branch.**

Action Taken by RGUHS

The Savings Bank Account held in Canara Bank, Jayanagar in the name of "Pension Trust - RGUHS" is closed with 'Zero' balance and the amount is transferred to SBI, Jayanagar, S B Account No. 64169884616 which is now converted in Sweep in Sweep out account. The matter of closure of the above said Canara Bank Account is informed to the Government and to the Paper Laid Down Committee on 21.09.2022 vide letter quoted in the para 'a' above.

- c. In future all the transactions with the Canara Bank shall be withdrawn**

Action Taken by RGUHS

At present, all the bank transactions with the Canara Bank is already withdrawn.

- d. In all the future Investments of the Surplus fund of RGUHS Canara bank shall not take part. A Note in this effect saying that Canara Bank is prohibited to take part in this Bid document, until further direction from the Syndicate.**

Action Taken by RGUHS

Already Canara Bank is prohibited to take part in Investments e-bids of RGUHS. In the recently concluded e-bid Investment process held on 06.10.2022, Canara bank was prohibited to take part. The same has

SUBJECT NO.III:

Approval of the Faculty Research grants for the year 2022-23

RGUHS had invited applications from the teachers working in the affiliated institutions of the RGUHS for consideration of release of research grants for the year 2022-23. Initially, applications were invited from 1st April 2022 and the last date was given up to 15th June 2022 for submission of application form. The last date was extended up to 30th June 2022 in view of requests from all the colleges. Wide-spread publicity was given for this purpose through advertisement in Newspaper, hosting of the information on RGUHS Official website and also individual letters addressed to the Principals of the Affiliated Colleges. The participation in the research methodology workshop was made mandatory for applying for research grants. However, faculty with two Research Publications in Indexed Journals or faculty with Research methodology workshop certificate obtained from any other organization, faculty with Ph.D. qualification or teaching faculty who have received grants earlier either from the this University or from any other funding agency are exempted from this pre-requisite clause. This time research methodology workshop was conducted in online platform.

As per the decision of the research expert committee the proposals received were evaluated by internal and external experts identified by respective Deans of faculty. The Committee decided to follow the process of evaluation similar to the one adopted in previous year wherein 80 marks was allotted for evaluation and a candidate had to score 56 or more (70% or more) marks for consideration. Only such of the proposals which are cleared by both internal and external evaluators were invited for interview.

The following table shows the details of the proposals received faculty-wise and the proposals cleared by both the internal evaluators and external evaluators.

1. The approval of Finance committee is sought for release of research grants for 32 Research Projects recommended by the Research Expert Committee for the year 2022-23 as per the **Annexure - 1**
2. Approval is sought for total budget release of **Rs. 9315000/- (Ninety three lakhs fifteen thousand only) for 32 research projects** for the year 2022-23. Out of this total amount, approval is also sought for First instalment release of 4657500/-, 2328750/- as second instalment, 1397250/- as third instalment, and 931500/- as fourth instalment.

Jayanagar to meet the monthly Pension disbursement activities, which was earlier kept in an SB Account of same Branch of the bank, which was opened for the purpose of RGUHS' other transactions. Pension Trust Account being different from RGUHS' account has its own / different PAN. Hence this pension trust account should be roll mapped with the Pension Account. This has been already done. But CA firm has opined in their Annual Accounts statements that there is no provision to release such grants / financial aids to other Institutions, from an Institute which is established as per 12AA / 10 (23) (C) Registration under Income Tax Act, i.e., by RGUHS. They also opined that this is out of the objectives of RGUHS, which may draw the attention of IT Department to raise the Income Tax demand or to cancel the Registration under 12AA / 10 (23) (C) and also IT Department would disallow the expenditure incurred for such type of grants. The same is expressed by the Finance Officer also. Further, there is no Budgetary provision made in the FY 2022-23 for the release of such Grants / Financial aids.

Any how, since already approval is given by the Syndicate and the sanction order is also passed by the administration for the release of grants / financial aids to some institutions, an advice was given to the administration,(i.e., to Hon'ble Vice-Chancellor) to make use of the unspent amount of Rs,800.00 Lakhs kept under Account Code 02004007 under the nomenclature "Establishment of 3D Technology / Smart Class Rooms in Government Medical Colleges under RGUHS" by changing the nomenclature as **"ESTABLISHMENT OF 3D TECHNOLOGY /SMART CLASS ROOMS IN GOVERNMENT MEDICAL COLLEGES UNDER RGUHS OR FINANCIAL AID /GRANT TO MEDICAL COLLEGES / INSTITUTIONS UNDER RGUHS"**.

Recently grant of Rs.2.50 Crores was approved by the Syndicate and the same was sanctioned by the administration to release to the Institute of Gastroenterology Science and Organ Transplantation, Bangalore. Accordingly, grant is released to the said institution as per the sanction order.

Hence approval is sought, to change the nomenclature as said above and also to the grant released to the Institute of Gastroenterology Science and Organ Transplantation, Bangalore under Account Head 02004007 under the changed nomenclature.

In future also, the expenditure for the already approved proposals of the similar kind of expenditure may be booked under this Account Code only, i.e., 02004007, under the changed nomenclature.

In the University, since its inception in the year 1996, all bills related to the examinations works, like the bills of TA/DA, Remunerations, Honorariums, etc. And Bills of Local Inspection Committees and Meetings of all types, Bills related to Research activities etc., which are received in the Finance Section directly either by the Institutions or by the claimants were priced and paid and also being paid directly by the Finance Officer without any sanction order by the administration, since it is received in bulk / huge quantities. For example - the examination related bills like Observers and Squad Bills,

Theory and Practical Staff Remuneration, Digital Valuation, Observers bills related to Web streaming, Bills related to Question Paper Setting and Scrutiny, Stationery Collection bills etc.,. And also other bills such as Dissertation bills, P.hd Synopsys and progress report Bills, LIC and other meeting bills, Advance Research paper Scrutiny bills etc. These bills are paid after considering the attached documents like the Duty Order, Attendance etc. These bills are received in hundreds, some times in thousands. For the smooth functioning of the payment process, to avoid the delay payments, and also to avoid work load at examination and administration sections, these bills are received at Finance Section directly and payments are released.

In the recently released Draft Audit Report of 2020-21 by the Statutory Auditor, i.e., KSAD, the procedure of releasing the payments for all such bills without the sanction of Registrar (Evaluation) / Registrar is objected.

If any decimals occurring during individual evaluator total marks awarded by the examiner shall be rounded off to the next higher value for the purpose of computation of results”</p> <p>This ordinance shall made applicable for evaluation of Answer scripts of all undergraduate Medical, Dental Pharmacy, Ayurveda, Homoeopathy, Unani, Nursing, Allied Health Sciences, BPT, BNYS courses except for the students admitted to BAMS and BUMS on and after 2021-22.</p> <p>However, Hon’ble High Court of Karnataka, Bengaluru in Writ Petition Number 31335/2019 dated 10.08.2022 ordered for valuation of answer scripts by a set of Four Evaluators in terms of regulation 13(2) of the Graduate Medical Education Regulations, 1997, forthwith.
