Sub: Revised Rules governing Fellowship programmes under continuing professional Education Scheme in Rajiv Gandhi University of Health Sciences, Bangalore.

In exercise of powers conferred under Section 23(2) vi of RGUHS Act 1994, the Senate at its meeting held on 27/03/2008, has been pleased to amend the existing Revised Ordinance governing Fellowship programmes notified under the University Notification No. ACA/Fellowship/Rules-1/2006-2007, dated 22/09/2006 and in Notification of even no dated 20/02/2007 as follows:

The amended Rules shall come into force with immediate effect.

Diploma with 3 years experience in Clinical Subjects are also eligible for pursuing fellowship programmes incase MS / MD candidates are not available in Clinical Subjects.</p> <p>OR</p> <p>ii. After DM/MCh in case of Medical Faculty.</p> <p>OR</p> <p>iii. Three years after Ph.D in other faculties.</p>
