### Preamble:-

The Examination Reforms Committee was constituted consisting of experts drawn from all faculties to discuss the reforms in the existing examination system at RGUHS. The Committee met several times and discussed the issues related to UG and PG examinations in depth. To maintain the high standards of education at PG level the committee strongly recommended to abolish the Gracing of marks for all Post Graduate courses. The matter was discussed extensively in the Joint meeting of Examination Reforms Committee and the Committee constituted to look into grievances of students pertaining to examination related matter on 25/06/2008. The Joint Committee also recommended the abolition of Grace Marks for all PG courses at RGUHS from the academic year 2008-09 and onwards and hence this Notification.

## **NOTIFICATION**

In exercise of the powers conferred under section 13(1) of the RGUHS Act 1994, the Hon'ble Vice-Chancellor in super cession of all Ordinances governing gracing for all PG courses referred to above, has approved the following amendment to the Ordinance governing grace marks for PG courses.

# RGUHS Ordinance (Amended) - 2008 relating to abolition of gracing for all Post-Graduate courses conducted by RGUHS.

No grace marks will be awarded for Theory / Practical / Clinical / Viva-Voce Examination in any PG course conducted by RGUHS.

This Ordinance is applicable for the students admitted to PG Course from the academic year 2008-09 and onwards.
