It is observed that the students passed or have become eligible to take admission to the next higher class after the supplementary examination are being allowed to appear for the next higher class examination within six months of the student becoming eligible to go to the next higher class in Pharm-D/ Pharm-D Post Baccalaureate courses. This is in total violation of the norms stipulated by P.C.I and RGUHS. Hence, it is made clear that there is no odd batch system in Pharm-D. The following conditions have to follow strictly while issuing examination application forms to the students of pharm-D and Pharm-D Post Baccalaureate courses.

- (1) All the students who have appeared for all the subjects and passed all the subjects the first year annual examination are eligible for promotion to the second year and so on. However, failure in more than three subjects (Four or more) shall debar him/her for promotion to the next year)
- (2) If the candidate becomes eligible in supplementary examination (by passing the failed subjects), he/she must wait for next academic year to join for the next year (in June following year). There is no odd batch or midstream batch.
- (3) Before entering into the third year the student has to clear all the first year subject. Similarly, before entering into the 4th year the candidate should clear all the second year subjects. Further before entering into the fifth year he/she has to clear all the third year subjects.
- (4) Candidate can start internship only after clearing all the five year subjects and after declaration of fifth year results.

The Principals of the colleges conducting Pharm-D and Pharm-D Post Baccalaureate courses are hereby informed to follow the conditions referred supra strictly. Any deviation in this is regard is viewed seriously and Principals concerned will be held responsible for all consequences.

If inadvertently any applications are issued for the ineligible candidates, the Principals are hereby informed to communicate the same to Registrar (Evaluation) to stop such ineligible candidates from appearing for **Nov/Dec 2017** examinations. This will come into force with immediate effect for those who have been admitted for the academic year 2016-17 and onwards. **The Circulars of even number dated 11/04/2017 & 26/04/2017 has been withdrawn**.
