Whereas, the National Medical Commission vide its communication cited under ref (1) above, published the Competency Based Medical Education Curriculum (CBME) Regulations – 2023.

Whereas, the National Medical Commission has issued a Corrigendum vide ref (2) above, regarding criteria for passing in a subject.

Whereas, the National Medical Commission has issued a Public Notice vide ref (3) above, stating that the consideration of the passing criteria issued through Corrigendum is not possible for retrospective effect.

Whereas, the Board of Studies of RGUHS have deliberated on the subject, made recommendations to implement the CBME Regulations – 2023 under RGUHS vide ref (4) above.

Whereas, the Committee of Academic Council recommended to implement the CBME Regulations- 2023 vide ref (5) above.

Whereas, in exercise of the powers, conferred under section 35 of the RGUHS Act, 1994 approved the recommendations of the Committee of Academic Council vide ref (6) above.

Hence, it is notified that the Competency Based Medical Education Curriculum (CBME) Regulations – 2023 issued by National Medical Commission vide ref (1) above has been implemented mutatis mutandis for students admitted to MBBS course since 2019- CBME Batch studying under RGUHS and shall come into force with effect from 01.08.2023.
