### **NOTIFICATION**

**Sub**: Guidelines for allotment of centers for UG Nursing Theory examination, Digital paper valuation & Practical examination center for Undergraduate Degree examination in Nursing

**Ref:** 1. Minutes of the BOS-UG-Nursing meeting held on 02.06.2022 2. Minutes of 172<sup>nd</sup> meeting of Syndicate held on 02.09.2022 & 05.09.2022.

As per the resolution of 172<sup>nd</sup> Syndicate meeting held on 02.09.2022 and 05.09.2022, Agenda No.7, Page No. 91 & 92, it is resolved that, the following are the guidelines to be followed by all RGUHS designated UG Nursing Theory/Digital paper valuation/Practical examination centers:

## PART.1: Guidelines for allotment of Theory examination Center:

- 1. The center shall have seating capacity minimum of 250 candidates per session.
- 2. Availability of Audio enabled CCTV along with Web streaming facility, high Speed Internet (2 lines), Power Backup and facility for Peripheral Scanning.
- 3. The priority for allotting Theory Centers, shall be emphasized on the basis of having a parent Medical /Dental / AYUSH/ Pharmacy College.
- 4. Institution shall have minimum of one out gone batch. Distance of Tagged colleges should be within the radius of less than 40 kms for Rural Area and less than 10 kms for Urban Area. However, the decision of ELEC & MPC Committee shall be considered in allotting the centers.
- 5. The Final list of Theory examination centers should be hosted on the RGUHS website at least 10 days prior to the commencement of Theory examination.

# Part-2: Guidelines for allotment of digital theory paper valuation center:

- 1. The RGUHS recognized Digital Paper evaluation centers shall have minimum of 5 years of active existence with one out gone batch at the time of allotment of Nursing Digital Valuation center.
- 2. The College should have Nursing faculties with their active and BOEA panel approved TIN numbers (excluding Principal).
- 3. Shall Have at least 15 computers with advanced configurations: Intel Core i3 Processor, 4GB RAMS, 500GB Hard Disk, web camera enabled and 100mbps speed Broad Band width of Internet Connection.

## Part-3: Guidelines for allotment of UG Nursing Practical Examination Center:

- 1. All designated theory examination centers shall consider for allotting Practical Examination to conduct as Exam Centers.
- 2. Institution having Parent Hospital.
- 3. The Practical exam center shall have all Nursing specialty teachers/faculty with TIN numbers and approved in BOEA Panel.
