As per above mentioned subject and direction of Indian Nursing Council. I would like to draw your attention that, KSNC has taken decision to conduct examination in lieu of Mercy chance for 2nd year PBBSc & 2nd Year MSc Students, who have completed double the duration of the course.

Further eligibility criteria for appearing for examination are as follows

1. Students who have completed and passed 1st Year Post Basic BSc (N) examination and were not able to clear the second year
2. Students who have completed and passed 1stM.Sc(N) examination and were not able to clear the second year.
3. Students who have completed the Theoretical and clinical requirements and the same needs to be endorsed by the principals of the respective Colleges.

Note : Mercy Chance is not applicable to candidates who have discontinued or re-joined the course.
