Preamble: -

The Government of India, Ministry of Health and Family Welfare, New Delhi, vide Letter No. V.12025/14/2025-DE dated 05.02.2026, has decided to grant a relaxation of two years to BDS students who were admitted during the academic year 2015-2016 and are currently in the final year of the BDS course or in the internship year only. It has also been specified that this relaxation is a special one-time measure. Subsequently, the Dental Council of India, vide its letter dated 23.02.2026, communicated the above decision. Further, the National Dental Commission, through its letter dated 21.05.2026, clarified that the effective date of implementation of this decision shall be 23.02.2026.

The matter was deliberated upon by the CAC and approved by the Syndicate. Accordingly, the following notification is issued:

In exercise of the powers conferred under Section 35(2) of the RGUHS Act, 1994, the Syndicate, in its 212th Meeting held on 23.03.2026, is pleased to approve the grant of a two-year relaxation to BDS students admitted during the academic year 2015-2016 who are currently in the final year of the BDS course or in the internship year only. This relaxation shall be applicable as a special one-time measure only.

The effective date of implementation of this notification shall be from 23.02.2026.

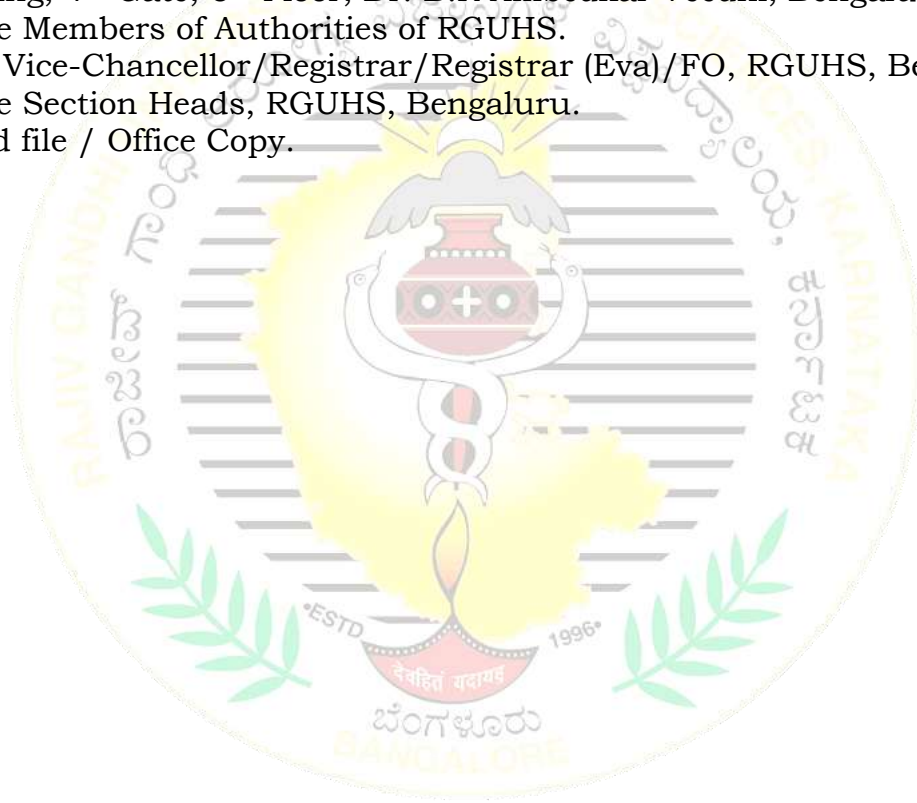
