NOTIFICATION

Sub: Withdrawal of double the duration limitation to complete UG & PG courses of Allied Health Science (AHS) Courses- Reg

RGUHS had issued a notification No. ACA/DCD/FTC/UG-PG/Course /412/2020-21, Dated: 16.12.2020 regarding "Maximum Duration for Course Completion". It was notified that the student admitted to any UG/PG courses under RGUHS shall complete the course and pass the final examination within double the number of years specified for that course from the date of admission to that course with effect from academic year 2020-2021 and onwards. Under the list of courses attached in the Notification at Sl No. 9, Course AHS UG/PG mentioned. The said notification was effective from 2020-2021 onwards.

However, the BOS in its meeting conducted on 06.06.2025 deliberated on the several of changes being happening in Allied Health Science courses under NCAHP. In view of these changes the BOS has recommended that the double the duration limit has to be removed for AHS students belonging to UG and PG courses. The same has been recommended in CAC meeting held on 04.09.2025.

Hence, the Syndicate in its 205th meeting on 06.09.2025 decided to remove the double the duration clause for both UG & PG courses of AHS. Hence, this notification.

In exercise of powers conferred under section 35 (1) of RGUHS Act, 1994 and Amendment Act, 2013 and in pursuance of decision of the 205th Syndicate meeting held on 06.09.2025, it is hereby notified that, the double the duration limitation to complete UG & PG courses of Allied Health Sciences has been withdrawn with effect from the ensuing examination.
