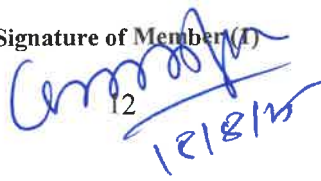

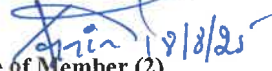

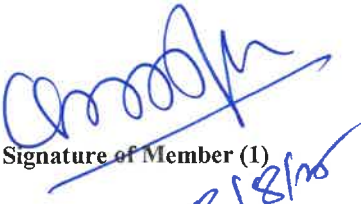

4. The check list should have specific comments wherever applicable.
