## NOTIFICATION

Sub: Amendment to the Ordinance, syllabus and scheme of examination pertaining to the Bachelor of Physiotherapy course, 2008.

## Preamble:

The Ordinance, syllabus and scheme of examination pertaining to the Bachelor of Physiotherapy course,2008 (in short 'BPT') makes provision only to the students who have studied science, in the 10+2 or equivalent and secured 45%, in case of Schedule Caste and Schedule Tribes 40%, marks in entirety in Physics, Chemistry and Biology. Further, the Ordinance made no provision for lateral entry to the candidates who has done Diploma in Physiotherapy (in short 'DPT') to pursue BPT course. Resultantly, the University felt it as expedient to amend Regulation 1.1 and 1.2, Ordinance, syllabus and scheme of examination pertaining to the Bachelor of Physiotherapy course,2008, to relax the eligibility criterion at the entry level and also in respect of lateral entry. Hence, this notification.

Ordinance NO RGU/AUTH/PHYSIOTHERAPY/048/2016-17 Date: 25.08.2016

In exercise of the powers conferred under Section 35 (2) of RGUHS Act, 1994, Regulation Governing Bachelor of Science Degree Courses in Physiotherapy 2008 is hereby amended and substituted thus –

After Regulation 1.1(iii), Ordinance, syllabus and scheme of examination pertaining to the Bachelor of Physiotherapy course, 2008, the following provision shall be inserted -

"OR

(iv) The candidate who has passed DPT of 3 (three) years duration from a recognized state Board/Institution can take lateral entry to 3<sup>rd</sup> year of BPT Course."

After the words "in the subject of Physics, Chemistry, Biology and English and" in Regulation 1.2, Ordinance, syllabus and scheme of examination pertaining to the Bachelor of Physiotherapy course, 2008, the following shall be inserted —

"Must have obtained not less than 35%, marks—in case of Schedule Caste, Schedule Tribes and Category -- I and 40% marks for others in entirety in Physics, Chemistry and Biology".

The above Ordinance shall come into force from the academic year 2016-17 and onwards.
