NOTIFICATION

Sub: Amendment to the Ordinance pertaining to the Regulations and Curriculum for Bachelors of Science Degree in Allied Health Sciences.

Preamble:

The curriculum in Bachelor of Science Degree Courses, of any discipline, in Allied Health Sciences is science oriented and the candidates from science background are more apt to pursue these programs than the students from other discipline since they do not study science, at their 10+2 or equivalent courses, with the required inputs in their pedagogical exercises on par with the science students. Resultantly, the University felt it is expedient to consider only the students who have studied science, in the 10+2 or equivalent, as eligible to seek admission to Bachelor of Science Degree Courses, of any discipline, in Allied Health Sciences and to treat the students from Arts and Commerce streams as ineligible. Accordingly, the University is desirous to introduce an amendment to Regulation 2(5) (b), Regulation Governing Bachelor of Science Degree Courses in Allied Health Sciences, 2008. Hence, this notification.

Ordinance No. RGU/AUTH/AHS/ 048 /2016-17 Date: 12.07.2016

In exercise of the powers conferred under Section 35 (2) of RGUHS Act, 1994, Regulation 2(5) (b), Regulation Governing Bachelor of Science Degree Courses in Allied Health Sciences, 2008 is hereby amended and substituted thus –

“candidates who have passed 10+2 (PUC or equivalent) in Science shall be eligible to join first year Bachelor of Science Degree Courses, of any discipline, in Allied Health Sciences.”

Explanation appended to Regulation 2(5) (b), Regulation Governing Bachelor of Science Degree Courses in Allied Health Sciences, 2008 is hereby repealed.

The above Ordinance shall come into force from the academic year 2016-17 and onwards.
