Sub: PCI approval is mandatory for all official procedures of RGUHS

Ref: 1. Judgement dated: 05.03.2020 passed by Hon'ble Supreme Court of India in Transfer Petitions (Civil) Nos. 87-101 of 2014
2. Pharmacy Council of India Letter No. 14-56/2019-PCI (A) / 9851- 55 dated: 11.03.2020

The Pharmacy Council of India (PCI) is a statutory body functioning under the ministry of Health & Family welfare, Govt. of India, New Delhi, to regulate the Pharmacy Education in the country. In the transfer petitions (Civil) No. 87-101 of 2014 dated 05/03/2020 passed by the Honorable Supreme Court in its Judgment upholding the "*Pharmacy Act, 1948 shall only prevail with regard to recognition and/or approval of Pharmacy courses/Pharmacy Institutions/Intake capacity & degrees & diplomas in Pharmacy*".

In the light of above Honorable Supreme Court Judgment, the **PCI APPROVAL IS MANDATORY** for all the official procedures of RGUHS such as Affiliation, Admission and Examination etc., from the academic year 2020-21 onwards.

The interested Institutions may obtain AICTE approval, if they so wish. However, RGUHS will insist only on PCI approval for all of its official procedures.
