- Further, it may be noted that the Bank Guarantee specified in the notification i.e. Rs.2500000/- for Five Years shall be submitted by the colleges for fresh courses at the time of issue of affiliation notification by the University i.e. after receipt of Govt./Apex body order.
- The colleges applying for fresh courses shall pay only processing fee of Rs.25000/- and application fee of Rs.1000/- per course. After scrutiny of the applications, the University will send the communication to the verified and accepted colleges. Then the colleges shall pay the remaining affiliation fee

deducting processing fee within the last date prescribed. After obtaining the approval from the Government, at the time of issue of affiliation notification from the University the colleges shall submit the Bank Guarantee.

5. With regard to instructions on payment of processing fee for fresh colleges and colleges applying for increase in intake, the information will be updated on RGUHS website.
6. When a college apply for MPT course for the first time, the Seats shall not exceed 3 seats per specialty. The fresh affiliation fee per speciality will be applicable (The revised ordinance governing regulation and curricula of MPT course 2020 shall be followed for grant of affiliation)
7. Existing MPT colleges may continue their admission with their existing total intake capacity as approved by RGUHS and Government of Karnataka but they must decide the choice of speciality and number of seats they would like to opt for in each speciality and offer them based on the availability of recognized guide for a particular speciality, availability of infrastructure and facilities. However, the PG intake in the institution shall not exceed 6 seats per speciality and shall have minimum 3 seats per speciality. The revised ordinance for MPT shall be adopted. The seatmatrix from the Government shall be based on the speciality submitted / applied by the College/Institution.
