Sub: Amendment to the Ordinances governing PG Courses Regulations of all faculties of Health Sciences in respect of "Change of Guide".

In exercise of the powers confirmed under section 35 of RGUHS Act 1994, and on the recommendations Deans, Committee of Academic Council and Syndicate is pleased to amend the Ordinances relating to the Clause of "Change of Guide" as follows.

In the Ordinances wherever the Clause is stipulated shall be substituted with the following and wherever the clause has not been stipulated shall be added with the following Clause.


Change of guide: (1) Where a registered guide left the college owing to voluntary retirement, superannuation, termination of service, discharge, dismissal or suspension from service, death or any other reasons the University may permit the Change of Guide, assigning reasons, by order in writing.

Explanation: "Any other" reasons means -

1. Non Maintenance of Student - Guide ratio;
2. Disability of the Guide to Guide the student;
3. Guide on Sabbatical leave;
4. Unauthorized Absence of the Guide;
5. Irregular Attendance of the Guide;
6. Student complaint against the guide;
7. In the event of guide's degree not valid or derecognized;
8. If the guide is facing disciplinary action;
9. When the guide is transferred.

(2) The head of the Institution shall recommend the name of guide to the University, in the proforma Prescribed, by recording the reasons for the "Change of Guide".

This Notification shall come into force with immediate effect.
