Preamble:

The National Medical Commission had released the CBME Guidelines for the MBBS Students admitted from the academic year 2024 onwards. The same guidelines including the additional clarifications released by the NMC, were deliberated in the Pre and Para Clinical Board of Studies. The same is yet to be discussed in the Clinical BOS. However, before the students of 2024 appear for their clinical examinations, the same shall be discussed in the next clinical BOS meeting.

During the deliberations, the Board of Studies of Pre and Paraclinical subjects, the subject experts have unanimously agreed to implement the CBME-2024 Guidelines for the students of 2024 academic batch.

Hence, in the 198th Syndicate, the recommendation of the Board of Studies and the CAC was approved. Therefore, as per the decision of the 198th Syndicate meeting held on 07.02.2025, the following Notification is done.
