With reference to the above, I am to inform that, the Eligible / Qualified applicants of Ph.D Entrance Examination of 2017-18 had to submit their Preliminary Synopsis along with all the documents like No Objection Certificate from Head of the Department and the Institute, where he / she is employed, Head of the Department and the Institute, where the candidate intends to pursue the Ph.D course, Notification from the University recognizing the Department of the Institution/College as Ph.D centre for 2017-18, Notification from the University recognizing the guide, all year marks cards and Degree Certificate along with application for enrolment to Ph.D for verification.

After Verification/Scrutiny of the documents, the colleges selected by 21 students (details enclosed) were not recognized for the year 2017-18. Hence the Preliminary Synopsis submitted by the concerned candidates were rejected and they were not allowed to present the synopsis on the synopsis presentation date announced by the university during January 2018.

On elaborate discussion held on the Ph.D sub-committee meeting held on 23.03.2018, it was resolved that the candidates who were qualified in 2017-18 entrance examination for Ph.D, cannot be allowed to register for the academic year 2018-19. This will affect the prospective candidates who will appear for entrance exam for the academic year 2018-19. Hence it was decided that those candidates who were qualified for 2017-18 entrance examination and were not registered due to non-recognition of the colleges selected, have to appear for the entrance examination for the academic year 2018-19 along with other aspirants.

The entrance examination fees of eligible candidates for 2017-18 is waived off as one time measure.
