Amendment to the Revised Ordinance Governing Enrolment of Candidates for Research Leading to Ph.D in Various Health Sciences of RGUHS.

Preamble

The Ph. D Sub Committee chaired by the Hon'ble Vice Chancellor deliberated on the duration of the Ph. D course. In case where the candidate, Ph. D guide and the research department are in the same institution, the duration of the Ph. D course was of four years duration since 2003, and this clause was omitted in the Revised Ordinance under reference (1) (2) and (3) above which was amended from four years to five years in 2017 and onwards Ordinances. After detailed discussion, it was decided to retain the four years course duration in case where the candidate, Ph. D guide and the research department are in the same institution.

In exercise of the powers vested under Section 35 (2) of the RGUHS Act, 1994 and as per the orders of the Hon'ble Vice Chancellor the amendment notified on duration of Ph. D course In case where the candidate, Ph. D guide and the research department are in the same institution as below.

"Where the candidate, Ph. D guide and the research department are in the same institution, the Course duration for full time course is three years and for part time course it is four years for all faculty."

The above amendment shall be applicable to the scholars admitted to Ph. D course from 2017 batch onwards.
