**Preamble:-**

The tender was invited for the work of Construction of Video Conference Room in first floor and Furnitures to Meeting halls in the premises of RGUHS , Jayanagar, Bangalore vide Ref (1) and tender was opened on 11.02.2022 in which out of Eight bidders . M/s Darshil Enterprises, Bangalore was lowest (L-1). Under reference (2) M/s Darshil Enterprises , Bangalore submitted the work done certificate issued by the Executive Engineer, KRIES, Bangalore .But, Executive Engineer, KRIES, Bangalore confirmed that said work done certificate was not issued from their office. It shows that fake work done certificate was submitted by M/s Darshil Enterprises .Hence Hon`ble Vice Chancellor vide para (52)of this file instructed to blacklist and should be barred permanently for applying / participating in any tender called by the RGUHS. Also as per tender clause (31) “ (a) will reject a proposal for award if it determines that the Tenderer recommended for award has engaged in corrupt or fraudulent practices in competing for the contract in question”

Further, Sri Subramani Saguna Kumar was the 2nd lowest bidders (L-2) quoted for Rs. 21,93,816.50/-.The Negotiation was conducted under the chairmanship of the Finance Officer, Member Secretary with the 2nd lowest bidder. The 2<sup>nd</sup> Lowest bidder accepted to carry out the work at the negotiated price of Rs. 21,00,000/- (Excl. of GST) . The “Letter of Acceptance” was issued to Sri Subramani Saguna Kumar furnish the Security Deposit of Rs. 1,05,000/- and Unbalanced tender amount Rs. 1,06,889/- respectively vide ref (8).

Sri Subramani Saguna Kumar stated vide his letter ref (9) that "Cost of Materials are very high in the market. Hence, he can't execute the work with the negotiated amount". As per the tender terms and conditions vide (29) "Failure of the successful Tenderer to comply with the requirements of Sub-Clause 29.1 shall constitute sufficient grounds for cancellation of the award and forfeiture of the earnest money deposit" his EMD can be forfeited and awarding of tender is cancelled

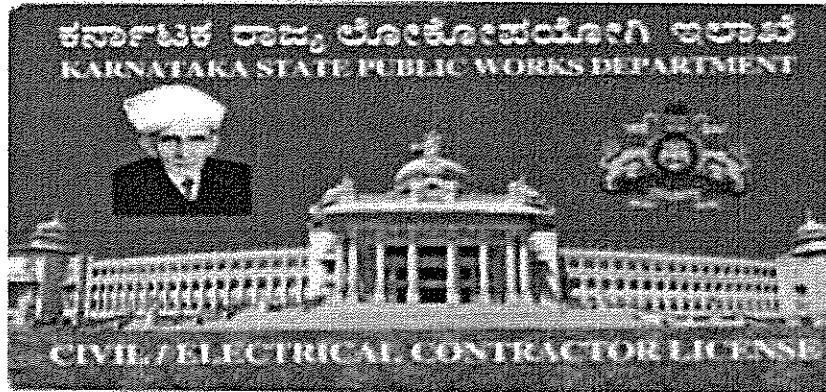

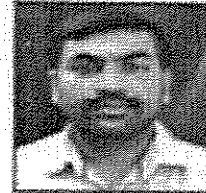

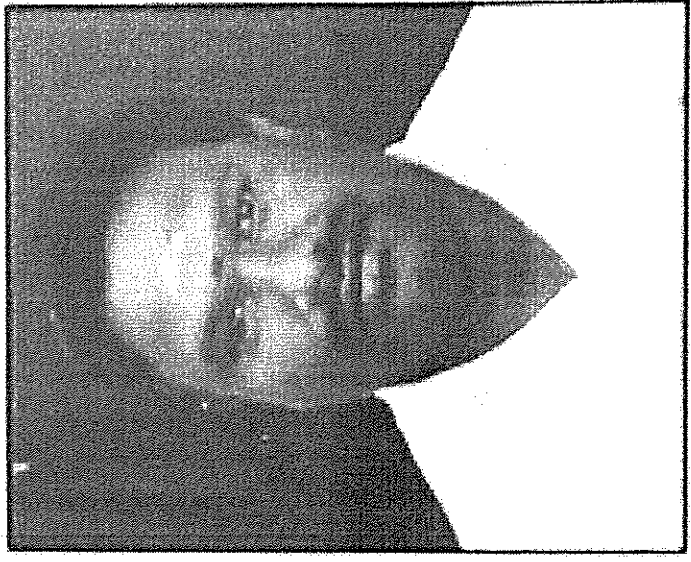
