## Circular

Sub: Display of Information in accordance to the Karnataka prohibition of violence against Medicare service personnel and damage to property in Medicare service institutions act 2009

Ref: Decision of the Senate in its meeting held on 23.03.2015

The Senate of RGUHS in its annual meeting held on 23.03.2015 resolved that it is mandatory for the colleges to follow "the Karnataka prohibition of violence against Medicare service personnel and damage to property in Medicare service institutions act 2009" and display the information in each floor of hospital and college premises as follows:

**Karnataka prohibition of violence against Medicare service personnel and damage to property in Medicare service institutions Act 2009**

"Any person/ offender commits any act in violence against Medicare service personnel or damage to property in Medicare institution shall be punished with imprisonment for a period of 3 years with a fine of 50000/- and non bailable. In addition to punishment the offender also is liable to a penalty of twice the amount of price of medical equipment and loss caused to the property".

ಆಸ್ಪತ್ರೆಯ ವೈದ್ಯೋಪಚಾರ ಮಾಡುವ ವೈದ್ಯರು, ಸಿಬ್ಬಂದಿಗಳಿಗೆ ಯಾವುದೇ ಕೆಡಕು ಉಂಟು ಮಾಡುವ, ಬೆದರಿಕೆ ಒಡ್ಡುವ, ಅವರ ಕಾರ್ಯಗಳಿಗೆ ಅಡ್ಡಿಯುಂಟುಮಾಡುವ, ಆಸ್ಪತ್ರೆಯ ಯಾವುದೇ ಆಸ್ತಿಗೆ ಹಾನಿ ಉಂಟುಮಾಡುವ ವ್ಯಕ್ತಿಗಳಿಗೆ ಮೂರು ವರ್ಷದ ತನಕ ಕಾರಾಗೃಹವಾಸ ಮತ್ತು 50 ಸಾವಿರ ರೂಪಾಯಿ ದಂಡ ವಿಧಿಸಬಹುದಾಗಿದೆ.

ಈ ಅಪರಾಧವು ಜಾಮೀನು ರಹಿತವಾಗಿರುತ್ತದೆ. ಆಸ್ಪತ್ರೆಯ ಯಾವುದೇ ಆಸ್ತಿ ಮತ್ತು ಸಲಕರಣೆಗಳಿಗೆ ಉಂಟಾದ ನಷ್ಟಕ್ಕೆ 2 ಪಟ್ಟು ದಂಡ ತೆರಬೇಕಾಗುತ್ತದೆ.
