### **NOTIFICATION**

Sub: Passing criteria for B.Pharm (Semester system)

The BOS (UG-Pharmacy) and Faculty in its meetings held on 18.09.2018 & 29.11.2018 respectively have resolved for modification of the present passing criteria which stipulates that the candidate has to score 50%, including minimum 40% marks in the end semester exam as under : -

***"The student has to score minimum 50% of total marks including internal assessment and End semester exams applicable from the academic year 2018-19 onwards"***

The said resolution was placed before the Academic Council held on 14.12.2018 and the Academic Council recommended that "Further discussion needs to be taken with regard to pass criteria for Under Graduate Pharmacy examination". The Syndicate approved the said recommendation. Accordingly, this subject was deliberated in detail in the CAC meeting held on 21.03.2019 and recommended to retain 40% passing criteria in theory for the University examinations of B.Pharm course semester scheme. Further, it was recommended to extend the benefit of grace marks – total 10 marks per semester, with a maximum of 5 marks in any subject, provided the candidate completes the semester.

Accordingly, it is notified that : -

- (1) The passing criteria for the University examinations of B.Pharm course semester scheme is retained as per notification dated 10.05.2017 referred at (1) above as under : -

#### **12. Promotion and award of grades**

A student shall be declared PASS and eligible for getting grade in a course of B.Pharm program if he/she secures at least 50% marks including internal assessment marks in that particular course provided a minimum of 40% marks in each Theory subject in the end semester University examination for passing of that subject.

- (2) As recommended by the BOS, Faculty and Academic Council and approved by the Syndicate in its meeting dated 14.12.2018, **the benefit of grace marks upto a total of 10 marks per semester, with a maximum of 5 marks in any subject, provided the students passes all the subjects of that semester, is extended to the B.Pharm semester scheme examination** with effect from the examination held during November/December- 2018 and onwards.
