Subject: Information regarding disbursement of the stipend, Duty hours of the Interns & Post Graduate Students and Duty room facilities

In compliance to the directions of the National Medical commission vide reference 2 quoted above, it is hereby informed to all the Affiliated Medical Institutions, that, all the institutions should invariably disclose the stipend disbursed to the interns and post graduates in their official websites.

It is also being heard that, some of the Institutes are taking back the disbursed stipend from the Interns and Post Graduate students, which is of unbecoming nature on the part of the Institutions. Hence, in this regard there will be surprise visit by the university, and if such information found correct during such visit, then the university will initiate appropriate action as per Norms/Law and intimate to National Medical Commission.

As per the PGMER-2023, vide reference No 3 quoted above, Post Graduate students are classified as full-time residents' doctors, expected to work for a reasonable hour with mandated rest times, with weekly off (subject to work exigencies) and the leaves as stipulated in the NMC – PGMER-2023 and also in the RGUHS Notifications. Hence, it is informed to all the affiliated Medical Colleges, to follow stipulated regulations by the National Medical Commission.

All the medical colleges are required to provide a proper duty room facility with neatly maintained toilets for the interns, post graduate students, teaching and non-teaching staff separately. It is also informed that, there should be separate male and female duty rooms for the interns, post graduate students teaching and non-teaching staff. In this regard, university may send an official for the surprise visit to check these facilities and if it is found that, these facilities are not provided, then such Institutions are liable for the appropriate action as per the Norms/Law and will be communicated to National Medical Commission.
