## **NOTIFICATION**

### **Sub: Revised Rules Governing the Fellowship Programme duration, Under professional Education Scheme in RGUHS**

The Syndicate in its 128<sup>th</sup> meeting held on 23.08.2017 has approved certain amendments to the Rules Governing Admission to Fellowship Courses. Hence, in exercise of the powers conferred under section 35(1) of RGUHS Act, 1994, the following amendments are notified to the Revised Rules Governing the Fellowship Programme issued vide Notification No. ACA/Fellowship/Rules-1/2006-07 dated 22.09.2006, under continuing Professional Education Scheme in Rajiv Gandhi university of Health Sciences, Bangalore.

1. **In clause 4- Admission Procedure**, the following shall be added in the end -
  - a. There shall be only one stream of admission every year during August for all Fellowship courses.
2. **In clause 5- Duration**, shall be substituted as under -

"The programme shall start during August every year on the dates as specified in Calendar of Events and the duration of all Fellowship Programmes shall be 18 months"
3. **In clause 7- Intake of Fellows**, the following shall be added at the end -
  - a. Increase in intake shall be limited to double the existing intake subject to fulfilling the conditions.
  - b. LIC inspection for the recognition of the institution/Hospital shall be carried out annually by the Subject Expert only.
  - c. As the admission is once in a year, institution/hospitals have to obtain the affiliation every year or they can apply for permanent affiliation if they are eligible as per the Permanent Affiliation Notification vide RGU/AUTH/110 SYN/Per. Aff/2014-15 dated 07.08.2017

4. **A new clause No. 15 is added to the said revised rules, which states as follows –**

**15. Revision of Syllabus :**

- a. Revision of the syllabus of the respective fellowship courses is to be done once in every three years.

The said Revised Rules comes into effect from the academic year 2018-19 onwards.
